## April 1 National Disability Rights Network (NDRN) Message Guidance and Toolkit

Every ten years the Constitution requires that the population of the United States be counted. Today, on Census Day 2020, the National Disability Rights Network (NDRN) joins organizations and people across the country to say that everyone counts!

NDRN is the nonprofit membership organization for the federally mandated Protection and Advocacy (P&A) Systems and the Client Assistance Programs (CAP) for individuals with disabilities. Collectively, the Network is the largest provider of legally based advocacy services to people with disabilities in the United States.

- The @uscensusbureau has an American Sign Language video guide available to help guide people completing the #2020Census. #ASL
- The online self-response method for the #2020Census is accessible to people with disabilities. Section 508 of the Rehabilitation Act of 1973 requires all federal agencies, including the @uscensusbureau, to make their electronic and information technology accessible to everyone, including people with disabilities.

- Households have the option to self-respond by phone during the #2020Census. The @uscensusbureau utilizes Telephone Device for the Deaf (TDD) technology to ensure that the phone self-response option is fully accessible during the 2020 Census.
- People in group living situations will be counted through a process known as the Group Quarters (GQ) operation.
